- Receive minimal rate of pay for the Child Care Assistance program (CCAP)
- Receive reimbursements from the federally-funded USDA Child and Adult Food Program
- Care for up to three children, including your own under 12 years of age
- · Earn income while pursuing your DCFS license

what is required to get a license?

While there is no fee to become licensed, DCFS applies health and safety expectations for you and your home child care environment and equipment. You must be at least 18 years of age and in good physical and emotional health. You must have a real understanding of the physical and emotional needs of young children, and most importantly, enjoy working with children.

initial licensing requirements

- · Completed, signed, and dated application for Home License
- Proof of physical and TB skin test for all members of the household (within past six months)
- High school diploma or GED
- Background checks for all household members or individuals working in the home, 13 years of age or older. Any
 person in the household 17 years of age or older must be fingerprinted
- Signed and dated Child Support Certification form
- · A written hazard plan
- 15 hours of pre service training, acquired within the year of application. Must include SIDS, SBS, CPR/First Aid, and Mandated Reporting
- Three references (not related to you)
